

Change in **Make Approval** feature: Removed **Approved** / **Conditionally Approved** options.



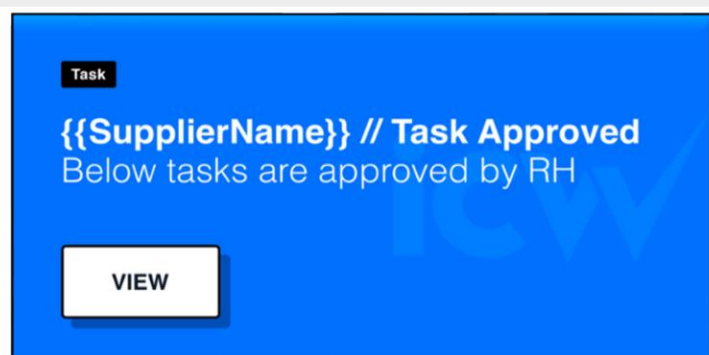

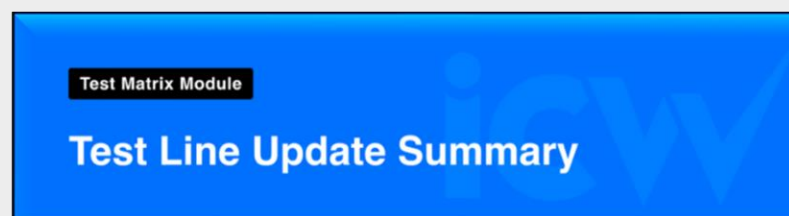
